COURSE DESCRIPTION

This course is an upper-division, reading-intensive seminar on the development of feminist theology. The overall goal of the course is to acquaint students with the motivations behind and variety of perspectives in feminist approaches to theological work. This acquaintance with some of the primary concerns of and works in feminist theology is then intended not only to expose students to a particular field of inquiry, but to provide them with a socio-critical hermeneutics that can be applied in their own thought and reflection on ultimacy. Specific objectives of the course include familiarizing students with many of the themes and issues treated by feminist theologians, as well as introducing them to the works of leading figures in the field.

Exams: Each student is required to complete a mid-term examination and a final examination. Details on exam requirements will be provided in class.

Theological Journal: Each student is required to maintain a journal throughout the semester that reflects upon their own understanding of or experiences of ultimacy, and how the readings and discussions impact their thinking on this topic. Journals will be collected periodically throughout the semester.

Weekend Ponderings: All students will be expected to initiate and contribute to on-line discussions over the assigned readings. Each week, two students will be assigned the task of posting a "thought" for the weekend, to which the class will respond. Initial postings must be made by noon on Saturday, and responses made by noon on Monday.

Attendance/participation: Attendance at and active participation in all class meetings is expected as this is an upper-level seminar course. Students should come to class having read the assigned readings and be prepared to discuss them. More than two absences during the course of the semester may result in the final grade being lowered one or more grades at the discretion of the instructor.
